

## TERMS AND CONDITIONS

<b>Organiser</b>	F&N Beverages Marketing Sdn. Bhd. (Reg. No. 196201000082 (004594-A))
<b>Contest</b>	Peraduan Magnolia Beli & Menang – Tabung Pendidikan (“Contest”)
<b>Contest Period</b>	The Contest starts at 00:00:00 on <b>1<sup>st</sup> April 2026</b> and closes at 23:59:59 on <b>31<sup>st</sup> May 2026</b> (“Contest Period”). The Organiser reserves the right to change, cancel, terminate or suspend the Contest at any time during the Contest Period without prior notice.
<b>Eligibility</b>	<p>The Contest is open to all individual legal residents of Malaysia aged 18 years and above as at the start of the Contest Period and with a valid identification document and residential address in Malaysia. (“Participant”).</p> <p>The following groups of persons shall not be eligible to participate in the Contest:</p> <p>(a) Employees of the Organiser and its group of companies and their immediate family members (spouse, children, parents, siblings, and their spouses);</p> <p>(b) Employees of the Organiser’s agencies, suppliers, and vendors associated with the Contest and their immediate family members (spouse, children, parents, siblings, and their spouses).</p>
